# CONDITIONS APPLICABLE TO ALL MEMBERS

1. All Memberships are subject to approval of the Board of Directors of Tracy Golf & Country Club and payment of the applicable Membership Fee.
2. Members who have been terminated in the prior 12 months are ineligible to apply for Membership.
3. The Applicant agrees to be bound by the Bylaws of the Tracy Golf & Country Club as they now exist or are hereafter amended.
4. The Applicant agrees to abide by all policies and rules of conduct and play established by the Board of Directors of Tracy Golf and Country Club, Club Manager or Golf Professional.
5. Members are responsible for the payment of dues and assessments as provided in the Bylaws. Members may only terminate future financial obligations to the Club by resigning and selling their membership in accordance with the Bylaws. *Memberships must be kept current by resigning members until the membership is sold/transferred.* Resignation is not effective until the sale or transfer is approved by the Board of Directors. The member shall be liable to the Club for all costs and expenses, including attorney's fees, of any collection or other legal action required to collect sums due the Club.

## PROMOTIONAL RATE CONDITIONS

(does not apply to family memberships)

Special membership promotions are run from time to time to allow new members to join for a reduced membership fee in exchange for a contractual obligation.
